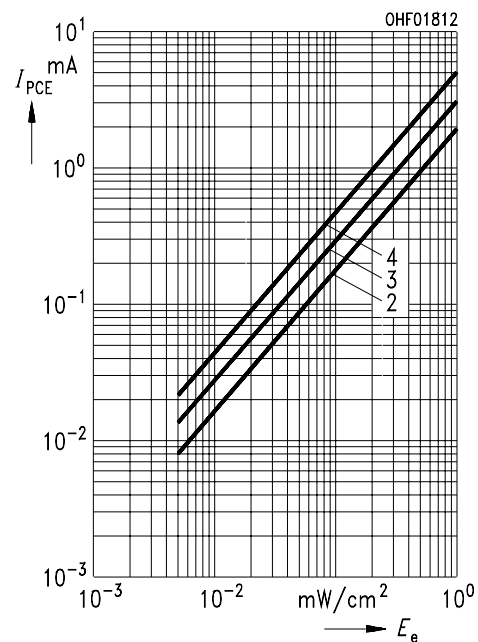

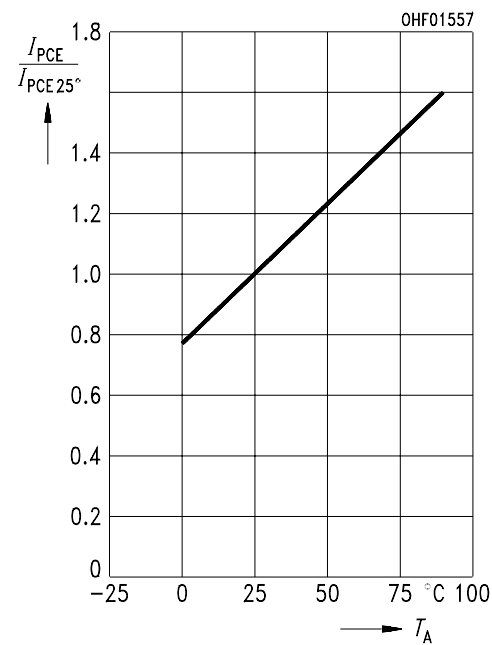


Dark Current ⁴⁾

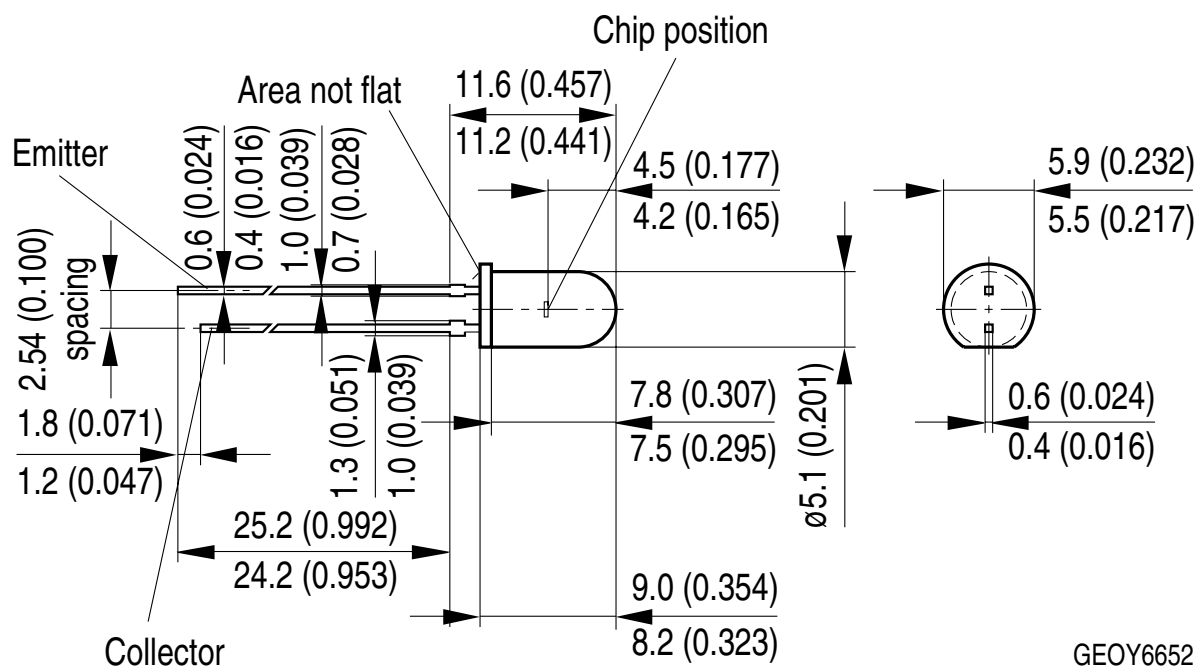

Dimensional Drawing ⁶⁾



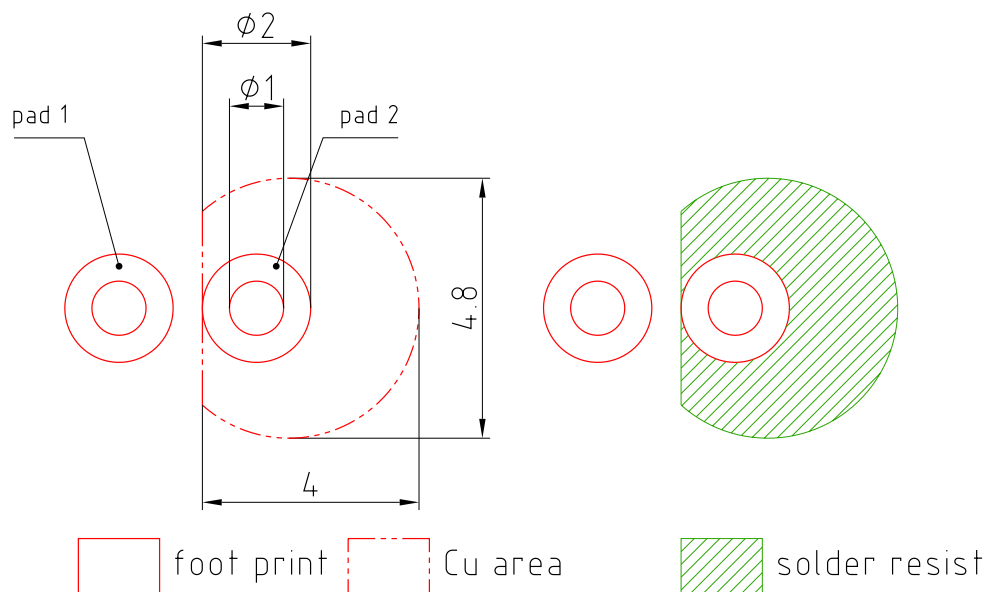

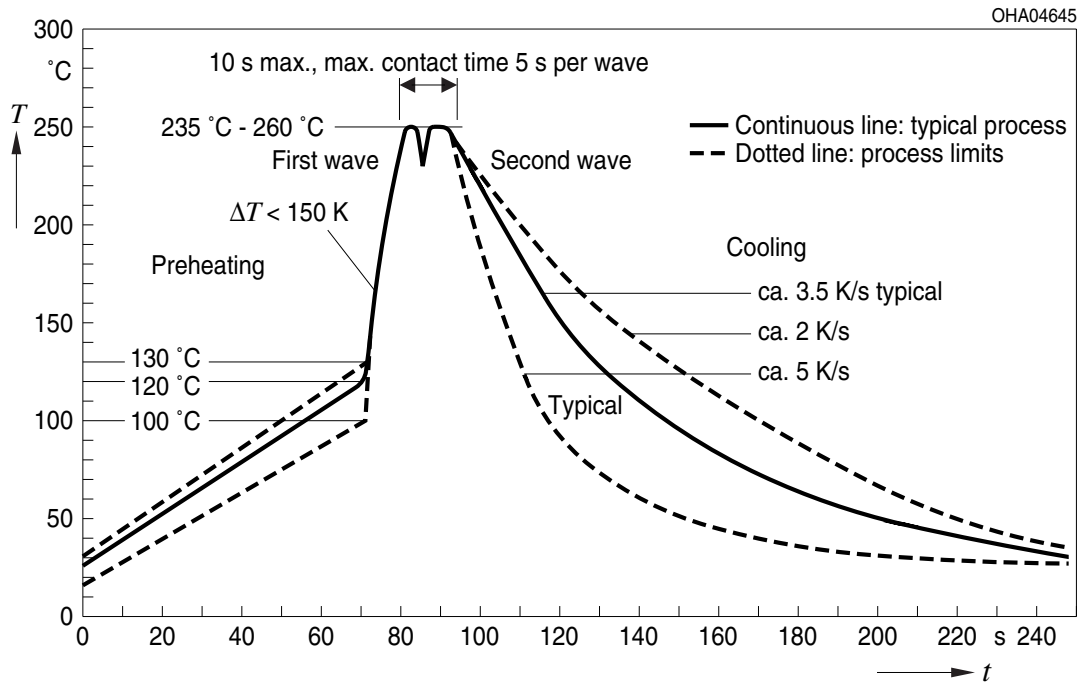
